



2014 – 2015 MBA AND MFIN INTERNAL AWARDS

Rotman offers many merit-based scholarships and award. All awards consider academic achievement, and many also consider demonstrated leadership, and/or community impact. Some scholarships may require financial need as well. Awards are given to students in their first, second, and subsequent years of the MBA and MFin programs.

The Recruitment & Admissions Office allocates Rotman entrance awards. Recipients are notified along with their offer of admission. There are also many scholarships and awards available for students in our programs, granted by the Program Services Office (PSO).

This document outlines the awards that were available for the 2014-15 academic year to use as a guideline for the types of awards that may be available for upcoming years. Award values and number of awards are approximate and confirmed on an annual basis.

DEFINITIONS

Program

For the purpose of this document the following terms refer to these specific programs and cohorts:

FT: Full-Time MBA and BASc/MBA programs, classes of 2015 and 2016; JD/MBA classes of 2015, 2016 and 2017; MGA/MBA classes of 2015 and 2016 AM/PM: Evening and Morning MBA programs, classes of 2015, 2016 and 2017

MFIN: Master of Finance program, classes of 2015 and 2016

Legal Status

Domestic: Canadian citizen or permanent resident

International: studying on a student visa and paying international student fees

Financial Need

Awards considering financial need will be assessed using the Financial Needs Assessment Form that is part of the online applications for Entrance Awards – Requiring Applications and In-Program Awards – Requiring Applications.

Ontario Residency

Some awards have been established as part of the Government of Ontario's Ontario Student Opportunity Trust Fund (OSOTF II) and Ontario Trust for Student Support (OTSS) programs, and must be awarded in compliance with those conditions. Under OSOTF II and OTSS, financial need and Ontario residency are the primary award conditions, and are defined as:

Financial Need: assessed using the Financial Needs Assessment Form – see Financial Need section above

Ontario Residency: must be a Canadian citizen or permanent resident AND satisfy one of the following criteria:

- 1. Student has always resided in Ontario
- 2. Ontario is the only/last province that the student has resided in for 12 consecutive months without being a full-time post-secondary student
- 3. Student who is considered married for OSAP purposes can be considered if the student's partner has resided in Ontario for at least 12 consecutive months immediately before the last day of the month in which classes began for the student's most recent period of full-time post-secondary studies and during this time, the student's partner was not enrolled in full-time post-secondary studies
- 4. A single dependent student can be considered if the student's parent(s), step-parent(s), legal guardian(s), or official sponsor(s) has resided in Ontario for at least 12 consecutive months immediately before the last day of the month in which classes began for the student's most recent period of full-time post-secondary studies.





ENTRANCE AWARDS

All students admitted to the MBA and MFIN programs are automatically considered for a Rotman School of Management Entrance Award by the Recruitment & Admissions Office and are notified in their admissions package if they will receive one.

Entrance Awards - Not Requiring Application

Students' admissions applications are reviewed to determine recipients for these awards. Recipients are notified in September.

ONTARIO GRADUATE SCHOLARSHIPS (OGS)

Jointly supported by the Ontario Government, the University of Toronto and generous donors to the Rotman School, these scholarships are designed to encourage academic excellence at the graduate level.
